Directions for use

Prior to use ensure that the drains are flowing and clear of blockages. Simply place the strip in the tray at the highest end and adjacent to the coil ensuring it's in contact with the water so that the resulting treatment will cover the entire tray. For trays with a central drain hole, place a strip at the highest point on either side of the drain (1 strip per one metre of condensate).

To ensure continued protection against slime and mould buildup, Jally® Strips should be inspected annually - additional strips can be placed in the tray alongside partially used strips. Use Jally® Strips in conjunction with CoolSafe® and DrainSafe® as part of your normal maintenance schedule.
